Summary of test results*	With reference to clauses 5.2 and 13.4.2 of standard EN IEC 62115, the battery compartment cover is not sufficiently secure: the compartment opens during the drop test referred to in clause 5.2 of the standard (the first time the toy was dropped, two of the three batteries were ejected). Risk of a child accessing the batteries.

Risk description (technical defect and consequences)*	If the battery compartment cover is not sufficiently secure, the batteries are easily accessible. If a child puts them in their mouth, the battery may release electrolyte that can be ingested and damage their digestive system.
